## Applications

- A non-refundable **admin fee of £5 is payable** on application by BACS.
- If you have NOT traded with us before, **images of your stall and items for sale** must accompany the application. Any such applications without images will not be put forward for the selection process.
- Applications or queries should be sent to **tradestands@farforestshow.co.uk**

## Arrival on site and show timings

- DO NOT BEGIN TO SET UP UNTIL YOU ARE SHOWN YOUR DESIGNATED TRADE SPACE
- Early set up is on Friday 7th August from 6pm to 9pm.
- On show days the site is open from 6am.
- Once you have checked in at the show office, and are issued with them, you and any staff must wear your wristbands to come and go from the site, otherwise you will be charged for entry during show days
- You MUST be set up, with your vehicle off site, by 9.30am.
- Show is open to the public from 10am to 5pm

## Insurance documents

- Exhibitors must have public liability insurance cover. We need to see a copy of your public liability insurance **with your application**.
- You must bring the original document with you to the show. We reserve the right to check insurance documentation.
- Exhibitors and Traders are solely responsible for the safe custody of their property. The Society, its officers and staff disclaim any responsibility and all liability in respect of loss (including damage, theft, fire, accident, etc). The Society strongly recommends that all Trade Exhibitors arrange adequate insurance to cover any loss

## Vehicle Movement and Parking

- **Vehicle movement is PROHIBITED between 9.30am and 5pm.**
- There is a one-way road system in operation between 6am Sat to 5pm Sun
- Vehicles must be parked in the designated parking field.
- Only vehicles with pre-booked Disabled Access Parking Permits are entitled to park in designated spaces on site.

## Risk Assessment

- Public safety is of paramount importance. You must complete your risk assessment questions on this application form. **Your application will be void if they are not completed**

## Environmental Issues

- ALL RUBBISH MUST be REMOVED from the showground by Traders.
- GENERATORS and OPEN FLAME APPLIANCES NOT PERMITTED.

## Payments

- Invoice payment must be made 2 weeks prior to the show weekend.
- Payment is by BACS only.

## First Aid

- On show days we provide First Aid response from professional medics. They are situated next to the Show Office or can be contacted by a Steward's radio.
- In an emergency, please dial 999 and give the post code DY14 9DA while also informing the First Aid team.

## Pitch Details

- If you have requested Electricity you need to supply your own extension lead. (PAT tested)
- If Signage is to be displayed it must not cause obstruction to walkways or other traders' stands.
- Showground staff have the authority to remove any such obstruction and have the stand rearranged at the expense of the trader.
- SUB-LETTING is PROHIBITED
- It is the responsibility of Traders to comply with Health and Safety and Trading Standards legislation.

- We accept no responsibility for conflict of interest between traders but will do our best to maximise space between similar stands.
- Mobile signal can be limited and unreliable at times and may affect card readers. Cash Back is available at the Show office
